



OFFICIAL RULES FOR THE NIKE WINNER STAYS TOURNAMENT (“TOURNAMENT”)

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.

NCAA/HIGH SCHOOL ELIGIBILITY. I UNDERSTAND AND AGREE THAT IF I AM, OR MAY BECOME, A STUDENT-ATHLETE IN THE UNITED STATES I AM RESPONSIBLE FOR MY OWN ELIGIBILITY AND/OR AMATEUR STANDING. I AM AWARE OF, AND AGREE TO COMPLY WITH, ALL APPLICABLE RULES, REGULATIONS, AND BYLAWS OF MY STATE ASSOCIATION, THE NCAA AND OF ANY OTHER GOVERNING BODY (“THE RULES”). I UNDERSTAND THE CONSEQUENCES OF ANY FAILURE TO COMPLY WITH THE RULES, INCLUDING BUT NOT LIMITED TO, LOSS OF MY ELIGIBILITY TO PARTICIPATE IN FUTURE ATHLETIC TOURNAMENTS IN ANY SPORT. 1) WHO IS ELIGIBLE?

THIS TOURNAMENT IS OPEN ONLY TO LEGAL PERMANENT US RESIDENTS WHO FOURTEEN (14) YEARS OR OLDER AT THE TIME OF ENTRY. EMPLOYEES OF NIKE USA, INC., ITS PARENT COMPANY, NIKE, INC., THEIR SUBSIDIARIES AND AFFILIATES (COLLECTIVELY “NIKE”), OR OF OTHER COMPANIES ASSOCIATED WITH THE PROMOTION OF THE TOURNAMENT, AS WELL AS THE IMMEDIATE FAMILY (SPOUSE, PARENTS, SIBLINGS, AND CHILDREN, AND EACH OF THEIR RESPECTIVE SPOUSES) AND HOUSEHOLD MEMBERS OF EACH SUCH EMPLOYEE ARE NOT ELIGIBLE. 3) WHEN CAN I ENTER?

THE TOURNAMENT REGISTRATION STARTS ON JULY 29, 2014 AND ENDS ON THE RESPECTIVE QUALIFIER EVENT DAY (THE “ENTRY PERIOD”).

4) HOW DO I ENTER?

- UPON VERIFIED REGISTRATION, TEAMS MUST ARRIVE TO THEIR RESPECTIVE QUALIFYING SESSION (“QUALIFIER”) AT LEAST ONE (1) HOUR PRIOR TO START TIME

 - SESSION 4, AUGUST 3RD AT 12PM (ARRIVE AT 11AM)

FINAL MATCHES:
THE WINNERS OF EACH OF THE FOUR (4) QUALIFYING SESSIONS, ALONG WITH TWO (2) HAND-SELECTED WILDCARD TEAMS WILL BE INVITED TO THE FINAL MATCHES TAKING PLACE MONDAY, AUGUST 4TH, 2014 AT 7:30PM. FINAL TEAMS MUST ARRIVE AT 1945 SE WATER AVE, PORTLAND, OR 97214 ([HTTP://GOO.GL/SEMBES](http://GOO.GL/SEMBES)) NO LATER THAN 6PM ON MONDAY.

THERE IS A LIMIT OF ONE (1) ENTRY PER TEAM. SUBSEQUENT ENTRIES WILL BE VOID.

TO ENTER THIS TOURNAMENT, YOU MUST BE IN GOOD PHYSICAL CONDITION, HAVE THE PHYSICAL CAPACITY (IN SPONSOR’S SOLE DISCRETION) TO PARTICIPATE IN ANY ACTIVITIES

5) HOW WILL WINNERS BE SELECTED?

SPONSOR WILL SELECT WINNING TEAMS BASED ON THE GAME RULES AND REGULATIONS (THE “RULES”) AS OUTLINED BELOW. TEAMS MUST BE PRESENT TO WIN.





THE RULES

TOURNAMENT REQUIREMENTS:

- ALL PLAYERS MUST REGISTER TO PARTICIPATE.
- AGE GROUP FOR THE TOURNAMENT IS 14+.
- THERE WILL BE A TOTAL OF 4-6 PLAYERS PER TEAM. 4 ON THE PITCH AND UP TO 2 AS SUBSTITUTES.

FORMAT

THE TOURNAMENT IS BASED ON FOUR BASIC RULES ("BASIC RULES"):

- 1) MAXIMUM OF 5 MINUTES PER GAME.
- 2) SCORE FIRST AND THE OTHER TEAM LOSES A PLAYER.
- 3) TEAM TO SCORE NEXT WINS AND STAYS ON THE PITCH.
- 4) WIN THE GAME AND EARN A POINT.

- AT THE END OF EACH QUALIFIER SESSION, THE ONE (1) TEAM WITH THE MOST POINTS IS DEEMED THE WINNER AND INVITED TO THE FINAL MATCH SESSION ON MONDAY
- IN THE CASE OF A TIE AT THE END OF A QUALIFYING SESSION, HEAD-TO-HEAD MATCHES WILL BE PLAYED UNTIL A TEAM WINS
- SPONSOR WILL ALSO SELECT SIX (6) PLAYERS FROM SATURDAY QUALIFIERS AND SIX (6) PLAYERS FROM SUNDAY QUALIFIERS TO REPRESENT TWO (2) WILDCARD TEAMS. THE WILDCARD TEAMS WILL ALSO BE INVITED TO THE FINAL MATCHES ON MONDAY.

GAME PROCEDURES:

- POINT SYSTEM: 1 POINT FOR A WIN, 0 POINTS FOR A 0-0 DRAW AND 0 FOR A LOSS. WINNER STARTS WITH THE BALL.
- FOLLOWING A TIE, TWO NEW TEAMS PLAY. KICKOFF IS DETERMINED BY ROCK, PAPER SCISSORS.
 - TEAMS WILL START THE GAME AT REFEREE'S REQUEST.
 - A MINIMUM OF 4 PLAYERS IS REQUIRED TO START THE GAME.
 - SUBSTITUTIONS SHALL BE UNLIMITED AND ON THE FLY.
- IN THE EVENT THAT ADVERSE CONDITIONS, NOT LIMITED TO WEATHER, NECESSITATE RESCHEDULING, CURTAILMENT, OR CANCELLATION OF GAMES, THE TOURNAMENT DIRECTORS SHALL HAVE ABSOLUTE AUTHORITY TO MAKE THESE CHANGES TO BEST SERVE THE INTERESTS OF THE TOURNAMENT AS A WHOLE, KEEPING IN MIND THE NEED TO SUCCESSFULLY IDENTIFY WINNERS WITHIN A CERTAIN TIME PERIOD.



THE RULES(CONT.)

PLAYERS EQUIPMENT:

- **ALL EQUIPMENT MUST CONFORM TO THE STANDARD FIFA RULES DUE TO INSURANCE REGULATION.**
- **CASTS AND BRACES: THE REFEREE FOR EACH MATCH WILL BE THE SOLE JUDGE AS TO WHETHER A PLAYER WEARING AN ORTHOPEDIC CAST OR BRACES SHALL BE ELIGIBLE TO PARTICIPATE.**
- **GOGGLES: PLAYERS WITH PRESCRIPTION GLASSES MUST WEAR SPORT GOGGLES WHILE PARTICIPATING IN OUR EVENT.**
- **FIFA'S GUIDANCE TO REFEREES HAS ALWAYS BEEN THAT A PLAYER MAY NOT USE EQUIPMENT OR WEAR ANYTHING, WHICH IS DANGEROUS TO HIMSELF/HERSELF OR ANOTHER PLAYER (INCLUDING ANY KIND OF JEWELRY).**

PLAYERS, COACHES AND SPECTATORS CONDUCT:

- **RED CARDED PLAYERS WILL BE DISQUALIFIED FOR THE NEXT TWO SCHEDULED GAMES. THIS INCLUDES SEMI-FINALS AND FINALS.**
- **1 YELLOW CARD AMOUNTS TO A 2 MINUTE SUSPENSION. 2 YELLOW CARDS AMOUNT TO A RED CARD. IF A PLAYER RECEIVES A TOTAL OF 5 YELLOW CARDS DURING THE TOURNAMENT, HE WILL BE DISQUALIFIED FOR THE NEXT GAME.**
- **CAPTAINS WILL BE RESPONSIBLE FOR THE BEHAVIOR OF THEIR FANS.**
- **ANY SERIOUS COMPLAINT OR MISCONDUCT OF A TEAM, ITS PLAYERS, COACHES OR FANS WILL BE REPORTED TO THE TOURNAMENT DIRECTOR AND ANY REFEREE ASSAULT WILL BE DEALT ACCORDING TO RULES LAID OUT BY THE LOCAL POLICE.**
- **THE SITE DIRECTORS HAVE THE AUTHORITY AND RESPONSIBILITY TO REMOVE ANY PERSON(S) FROM THE TOURNAMENT FOR ABUSES OF GOOD CONDUCT, IN ADDITION TO ANY SPECIFIC DISCIPLINARY ACTION BROUGHT BY ANY OTHER AUTHORITY.**
- **TOURNAMENT DIRECTORS MAY SUSPEND ANY OFFENDING MANAGER/COACH/PLAYERS FOR THE DURATION OF THE TOURNAMENT IF FURTHER DISCIPLINARY ACTION IS APPROPRIATE.**
- **ANY TEAM ENTERING OR ATTEMPTING TO ENTER A PLAYER INTO A GAME WITHOUT THE PROPER REGISTRATION AND OR HAVING BEEN PROCESSED THROUGH THE TOURNAMENT REGISTRATION PROCESS WILL RESULT IN A FORFEIT OF THE AFFECTED GAME; AN OFFENSE OF SUCH ACTION MAY RESULT IN IMMEDIATE ELIMINATION FROM THE TOURNAMENT.**

IF A TEAM OR AN INDIVIDUAL TEAM PLAYER DECLINES TO ACCEPT THE PRIZE, CANNOT VERIFY THEIR ELIGIBILITY OR HAS VIOLATED ANY OF THESE OFFICIAL RULES, THEN AN ALTERNATE ENTRANT OR TEAM MAY BE SELECTED, AT SPONSOR'S DISCRETION AND IF TIME PERMITS, IN HIS/HER PLACE FROM THE REMAINING ELIGIBLE TEAMS. ONLY ONE (1) ALTERNATE TEAM WILL BE SELECTED, AFTER WHICH THE PRIZE WILL REMAIN UN-AWARDED.

ALL POTENTIAL WINNERS ARE SUBJECT TO VERIFICATION BY SPONSOR, WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE PROMOTION. 6) WHAT CAN I WIN?

THE FINALISTS WILL WIN A NIKE PRODUCT PACKAGE INCLUDING, NIKEiD GOLD PACK (PLAYERS CAN CHOOSE TO ID GOLD MAGISTA OBRA, MERCURIAL SUPERFLY OR HYPERVENOM PHANTOM (\$265 – \$315), LUNAR GATO (\$100). APPROXIMATE RETAIL VALUE ("AVR"): \$365 – \$415.

ATTENTION STUDENT ATHLETES: THE PRIZE PACKAGE IS SUBJECT TO HEAD COACH/ATHLETIC DIRECTOR WRITTEN APPROVAL. 7) WHAT OTHER TERMS SHOULD I BE AWARE OF?

UNLESS PROHIBITED BY LAW, ENTRANTS AGREE TO ALLOW USE OF THEIR NAME, VOICE, CITY/STATE OF RESIDENCE, PHOTOGRAPH, AND/OR LIKENESS FOR ADVERTISING AND/OR TRADE AND/OR ANY OTHER PURPOSE IN ANY MEDIA OR FORMAT NOW OR HEREAFTER KNOWN WITHOUT FURTHER COMPENSATION, PERMISSION OR NOTIFICATION.

THE TOURNAMENT IS SUBJECT TO FEDERAL, STATE, AND LOCAL LAWS AND REGULATIONS AND IS VOID WHERE PROHIBITED BY LAW. IN THE EVENT THAT THE OPERATION, SECURITY, OR ADMINISTRATION OF THE TOURNAMENT IS IMPAIRED IN ANY WAY FOR ANY REASON, INCLUDING, BUT NOT LIMITED TO FRAUD, VIRUS, OR OTHER TECHNICAL PROBLEM, THE SPONSOR MAY, IN ITS SOLE DISCRETION, EITHER: (A) CANCEL OR TERMINATE THE TOURNAMENT; (B) SUSPEND THE TOURNAMENT TO ADDRESS THE IMPAIRMENT AND THEN RESUME THE TOURNAMENT IN A MANNER THAT BEST CONFORMS TO THE SPIRIT OF THESE OFFICIAL RULES; OR (C) AWARD THE PRIZE ACCORDING TO THE JUDGING CRITERIA FROM AMONG THE ELIGIBLE ENTRIES RECEIVED UP TO THE TIME OF THE IMPAIRMENT. THE SPONSOR RESERVES THE RIGHT IN ITS SOLE DISCRETION TO DISQUALIFY ANY INDIVIDUAL IT FINDS TO BE TAMPERING WITH THE ENTRY PROCESS OR THE OPERATION OF THE TOURNAMENT OR TO BE ACTING IN VIOLATION OF THESE OFFICIAL RULES OR IN AN UNSPORTSMANLIKE OR DISRUPTIVE MANNER. ANY ATTEMPT BY ANY PERSON TO UNDERMINE THE LEGITIMATE OPERATION OF THE TOURNAMENT MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAW, AND, SHOULD SUCH AN ATTEMPT BE MADE, THE SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW. FAILURE BY THE SPONSOR TO ENFORCE ANY TERM OF THESE OFFICIAL RULES SHALL NOT CONSTITUTE A WAIVER OF THAT PROVISION. IN THE EVENT SPONSOR IS PREVENTED FROM CONTINUING WITH THE TOURNAMENT OR THE INTEGRITY AND/OR FEASIBILITY OF THE TOURNAMENT IS SEVERELY UNDERMINED BY ANY EVENT BEYOND THE CONTROL OF SPONSOR, INCLUDING BUT NOT LIMITED TO FIRE, FLOOD, EPIDEMIC, EARTHQUAKE, EXPLOSION, LABOR DISPUTE OR STRIKE, ACT OF GOD OR PUBLIC ENEMY, SATELLITE OR EQUIPMENT FAILURE, RIOT OR CIVIL DISTURBANCE, WAR (DECLARED OR UNDECLARED), TERRORIST THREAT OR ACTIVITY, OR ANY FEDERAL, STATE OR LOCAL GOVERNMENT LAW, ORDER, OR REGULATION, ORDER OF ANY COURT OR JURISDICTION, INFECTION BY COMPUTER VIRUS, UNAUTHORIZED INTERVENTION, TECHNICAL FAILURES OR OTHER CAUSE NOT REASONABLY WITHIN THE CONTROL OF SPONSOR (EACH A "FORCE MAJEURE" EVENT OR OCCURRENCE), SPONSOR SHALL HAVE THE RIGHT, IN ITS SOLE DISCRETION, TO ABBREVIATE, MODIFY, SUSPEND, CANCEL OR TERMINATE THE TOURNAMENT WITHOUT ANY FURTHER OBLIGATION.

BY PARTICIPATING IN THE TOURNAMENT, ENTRANTS AGREE TO RELEASE AND HOLD HARMLESS THE SPONSOR, ITS PARENT AND RELATED COMPANIES, AND THEIR RESPECTIVE OFFICERS, DIRECTORS, EMPLOYEES, AND AGENTS (THE "RELEASED PARTIES") FROM AND AGAINST ANY CLAIM OR CAUSE OF ACTION ARISING OUT OF PARTICIPATION IN THE TOURNAMENT OR RECEIPT OR USE OF ANY PRIZE, INCLUDING, BUT NOT LIMITED TO: (A) UNAUTHORIZED HUMAN INTERVENTION IN THE TOURNAMENT; (B) TECHNICAL ERRORS RELATED TO COMPUTERS, SERVERS, PROVIDERS, OR TELEPHONE OR NETWORK LINES; (C) PRINTING ERRORS; (D) LOST, LATE, POSTAGE-DUE, MISDIRECTED, OR UNDELIVERABLE MAIL; (E) ERRORS IN THE ADMINISTRATION OF THE TOURNAMENT OR THE PROCESSING OF ENTRIES; OR (F) INJURY OR DAMAGE TO PERSONS OR PROPERTY WHICH MAY BE CAUSED, DIRECTLY OR INDIRECTLY, IN WHOLE OR IN PART, FROM ENTRANT'S PARTICIPATION IN THE TOURNAMENT OR RECEIPT OR USE OF ANY PRIZE. ENTRANT FURTHER AGREES THAT IN ANY CAUSE OF ACTION, THE RELEASED PARTIES' LIABILITY WILL BE LIMITED TO THE COST OF PARTICIPATING IN THE TOURNAMENT, AND IN NO EVENT SHALL THE RELEASED PARTIES BE LIABLE FOR ATTORNEY'S FEES. ENTRANT WAIVES THE RIGHT TO CLAIM ANY DAMAGES WHATSOEVER, INCLUDING, BUT NOT LIMITED TO, PUNITIVE, CONSEQUENTIAL, DIRECT, OR INDIRECT DAMAGES. ENTRANT AGREES THAT THE RELEASED PARTIES HAVE MADE NO WARRANTY, REPRESENTATION OR GUARANTEE, EXPRESSED OR IMPLIED, IN FACT OR IN LAW, RELATING TO ANY PRIZE.

8) HOW WILL DISPUTES BE HANDLED?

EXCEPT WHERE PROHIBITED, ENTRANT AGREES THAT ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF, OR CONNECTED WITH, THE TOURNAMENT OR ANY PRIZE AWARDED SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION, AND EXCLUSIVELY BY THE APPROPRIATE COURT LOCATED IN THE STATE OF OREGON. ALL ISSUES AND QUESTIONS CONCERNING THE CONSTRUCTION, VALIDITY, INTERPRETATION AND ENFORCEABILITY OF THESE OFFICIAL RULES, ENTRANT'S RIGHTS AND OBLIGATIONS, OR THE RIGHTS AND OBLIGATIONS OF THE SPONSOR IN CONNECTION WITH THE TOURNAMENT, SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF OREGON, WITHOUT GIVING EFFECT TO ANY CHOICE OF LAW OR CONFLICT OF LAW RULES (WHETHER OF THE STATE OF OREGON OR ANY OTHER JURISDICTION), WHICH WOULD CAUSE THE APPLICATION OF THE LAWS OF ANY JURISDICTION OTHER THAN THE STATE OF OREGON.

HOW LONG IS REGISTRATION OPEN?
