

## Participant agreement document

Please read the following carefully.

The term of “event” states in the document indicates “ALLDAY” 2 days basketball event hold in November 14<sup>th</sup> and 15<sup>th</sup> at YOYOGI park basketball court, transportation that relates to “ALLDAY,” activities run by NIKE and other events hold in YOYOGI park. I, for my own, and my heir to property, insurance companies, successors and assigns, will completely and permanently abandon all my rights to claim damages or loses happened in the event which may relates to Nike, Inc. and affiliated companies and subsidiaries, individual officers, directors, shareholders, employees, agents, distributors, representatives, contractors, successors, assigns and insurance companies. All of the events sponsors, advertisers, for volunteers and staff, as well as all of the owner or lessor of the facility to be used in conjunction with the event.
