FOR INDIVIDUALS UNDER THE AGE OF 18, A PARENT OR LEGAL GUARDIAN MUST COMPLETE THIS FORM ON YOUR BEHALF OR YOU WILL NOT BE PERMITTED TO PARTICIPATE IN THE TOURNAMENT.

I wish to participate in or attend the NIKE Football X Tournament (hereinafter referred to as the "Tournament") which has been arranged and managed by Nike European Operations Netherlands B.V. whose registered office is at Colosseum 1, 1213, NL Hilversum, The Netherlands ("NIKE") I hereby agree as follows:

NO PURCHASE REQUIRED TO ENTER OR WIN THE TOURNAMENT

No purchase is required to enter the Tournament. By entering this Tournament, individual entrants ("Entrant") accept and agree to be bound by these Terms & Conditions ("T&Cs")

IMPORTANT NOTICE FOR AMATEUR ATHLETES

Entrant is responsible for ensuring that their participation in this Tournament does not affect their eligibility as an amateur athlete. Please check with your amateur athletic association for the rules that apply to you. To the maximum extent permitted by applicable law and with the exception of liability for gross negligence or willful misconduct of NIKE, NIKE is not responsible or liable for your participation in this Tournament resulting in your ineligibility as an amateur athlete

WHO IS ELIGIBLE?

- a. Residents of UK & Ire who are 16 years or over at the start of the Registration Period and who are a Nike member. Membership is free. You can sign up by visit Nike.com for your country and selecting 'JOIN'. Entrants aged between 16 and 18 must have consent from their parent or legal guardian to participate in the Tournament.
- b. amateur football players. Professional or semi-professional football players, those who are bound by a football-related contract or who are otherwise associated with a football club or academy are not eligible to enter or participate in the Tournament.

HOW WILL TEAMS BE SELECTED: Entrants will be selected by a team of NIKE judges based on the creativity and originality of their justification made during registration as to why they should be selected.

INDEMNITY: To the maximum extent permitted by applicable law, I hereby irrevocably and unconditionally agree to hold harmless, indemnify and reimburse NIKE from and against any claim, sum, costs, damages or expenses (including reasonable legal fees) arising in connection with any accident, loss or damage arising out of my attendance or participation in the Event.

LIABILITY: To the maximum extent permissible under law, I agree that any liability of NIKE relating to my participation in the Event is excluded except in case of negligence or wilful misconduct.
